DS Board of Directors Election

The nominee to replace Tamar Evangelestia-Dougherty:

• Regine Heberlein, Princeton University (term 2023-2025, renewable)

Regine Heberlein is a data analyst at Princeton University Library. She started her career in Special Collections and at the time described herself as a tech-adjacent archivist; she now describes herself as an archives-adjacent tech person... until someone gives a better name to that liminal space where data capture and data processing come together to make data dance. Regine is a current member of the Experts Group on Archival Description (EGAD) at the International Council on Archives (ICA) and current co-chair of the Technical Subcommittee for Describing Archives: A Content Standard at the Society of American Archivists (SAA). She also currently serves on the metadata subgroup of the ArchivesSpace Technical Advisory Council. In the past she has served on the joint task force on the Art and Rare Materials BIBFRAME Ontology Extension and the SAA Technical Subcommittee for Encoded Archival Description. Regine has long nurtured an interest in linked data for cultural heritage description. She sees great potential in linked data for transcending institutional and national borders and contextualizing—sometimes re-contextualizing—material traditionally described in isolated local systems. Her ears pricked up when she saw L.P. Coladangelo present at virtual LD4 last year—someone doing linked data for production, not a proof of concept, not a pilot, not a grant project, but production for real?! She had to know more immediately. She began serving as Princeton's member representative this past summer, and is thrilled to contribute to Digital Scriptorium wherever needed as a member-at-large on the Board of Directors.
