**10:10 - 10:30 am Reports**

- Executive Director's Report: Lynn Ransom
  - Highlight the strength and vitality of DS organization
  - Successful completion of the development phase of the DS Catalog
  - After today's meeting, DS will welcome two new board members
  - Added ten new member institutions, for a total of 52 members, ten over the course of the past year
  - DS Beta launch in 2023, now with over 12,000 records
  - Finance Committee has reviewed the member fee schedule, recommending an increase to ensure future sustainability and sensitivity to a commitment to equity among members
  - DS Project and Data Manager (PDM) position was made full time for at least a year, with hope that increased dues and increased membership can extend that appointment
  - Penn Libraries, on behalf of DS, received a \$17,000 grant from the Gladys Krieble Delmas Foundation, to appoint Rose McCandless as the Manuscript Data Curation Graduate Fellow (MDCF)
  - Board initiated additional fundraising, reaching \$14,500 of its \$20,000 goal, extending Rose's appointment through December 31
  - PDM has established data management workflows and protocols that have streamlined data collection and transformation
  - MDCF has worked with four institutions to create new descriptions

- PDM and MDCF will be sharing and publishing work with academic communities, such as at the Schoenberg Symposium
- Bylaws Committee has recommended changes and updates, including splitting apart the President and Executive Director (ED) positions
  - Long term goal of bringing on a more permanent Executive Director
- Sue Steuer nominated as President, new members to be elected, others to be renewed: all work of the Nominating Committee
- David Faulds and Vanessa Wilkie rotating off Board
  - Thank them for their work
- Thank University of Kansas for hosting
- Treasurer's Report: Vanessa Wilkie
  - VW stepping away from the Board after nine years
  - DS remains financially healthy, even with expansion of work
  - ED and PDM manage day-to-day work related to finances and invoicing, working closely with Treasurer under Board oversight
  - Use QuickBooks software to manage finances, increasing efficiency and transparency
  - All dues-paying members have paid dues
  - Largest expense is PDM's salary
  - Normal operational costs include subscription fees and travel expenses for PDM and MDCF
  - 2024 revenue: \$96,868.12
  - 2024 expenses: \$77,232.98
  - Penn awarded \$17,000 Delmas grant restricted to MDCF
  - Additional \$14,500 fundraised
  - Reassessed member fee schedule to be presented for vote
  - Checking account balance: \$19,635.14
  - Savings account balance: \$13,007.33
- Member Services Report: Sue Steuer
  - With platform redevelopment there has been renewed interest in joining
  - Members joining since the last annual meeting: Ohio State University, Science History Institute, and Vassar College
  - Confirmation of membership at this meeting: University of Chicago, University of Dayton, Newberry Library, Rochester Institute of Technology, University of Rochester, University of Wisconsin-Madison, Williams College
  - Formation of Membership Committee: led by a Director with representatives from member institutions
  - MDCF worked on recruitment this year as well as descriptive services
- Advisory Council Report: Lisa Fagin Davis
  - Read by LR
  - Advisory Council has transitioned from supporting the development and launch of the new platform to supporting its implementation and growth
  - Supporting work of MDCF to make decisions about records that may be out of scope, since the chronological and geographic scope of the data set has expanded
  - Terms ending for LFD, Elizabeth Hebbard, Andrew Hicks, and Eric Johnson
    - All four have been recommended for renewal of three year terms
- Friends of Digital Scriptorium
  - LR: no formal report but fundraising effort has created The Friends of Digital Scriptorium
  - Goal to contribute financially to support DS mission for digital access and appreciation of significant but understudied materials
  - Currently supports MDCF work
  - Wonderful donors already supporting
  - Donations can be made online or with a check sent to LR's Penn address

***The State of the DS Catalog***

- Thank members of the Board, Doug Emery as technical advisor, Rose McCandless as MDCF
- State of the Catalog is strong
- Grew from 1,200 records in 2023 to 12,000 this year
- 14 institutions represented to now 35
- Data available both in front-end interface and back-end SPARQL querying
- Description of enrichment process managed through authorities
- 1,200 different metadata values for language linked to 132 languages
- 1,700 place information strings linked to 686 different places
- 12,000 titles that we standardize to over 4,000 titles
- 10,000 versions of names that reconcile to nearly 6,500 names
- 18,000 subject and genre values that accord with 5,100 authorities
- Multiple encoding standards supported, including a DS-CSV
- Presentation at upcoming LD4 conference
- Improved in-scope review
- Faster and more reliable workflows
- Google Analytics available through Penn Libraries: 2,500 active users, 17,000 views
- Examine usership by geographic location
- Users coming back, new users being engaged
- Blog post being written about WMU item, which drove traffic
- Significant periods of time people are looking at records
- Able to examine cross-referenced searches through facets
- Refreshes to incorporate new information and corrections
- In-situ fragment metadata creation pilot project
- Upcoming Schoenberg Symposium talk and MDCF LD4 lightning talk

- DS to Wikidata project
- Question from RH about EAD: not currently supported, but working toward a workflow for processing EAD records; hoping for a real-life test case

### **Bylaws Revisions**

Adoption of revisions proposed by Bylaws Committee (below)

After a review of the current bylaws by the Digital Scriptorium Board last year, the Bylaws Committee has proposed some updates to the Digital Scriptorium bylaws, to be put to a ratification vote at this year's meeting. Summarized below, the most notable changes include:

- 1. Clarification of the role of the Partnering Institution of DS (formerly referred to as the “Technology Host”) to account for both the technological and administrative support the Partnering Institution provides DS (see Article VII, Section C).
- 2. Separation of the roles of President of the DS Board and Executive Director of DS and clarification of the Executive Director role as distinct from that of the President (see Article III, Section M).
- 3. Updates to the sections pertaining to Data Contribution, DS Property, and Termination/Withdrawal to account for the fact that these matters are now addressed in Memoranda of Understanding between DS and member institutions (see Article VII, Sections E, F, and G).

**Fee Schedule Revision**

Approve adoption of fees schedule revision proposed by Finance Committee (below)

After several months of review and discussion amongst the Finance Committee and the Executive Director, we have developed a slightly tweaked fees model that feels fair and balanced. If approved, the fees for each member will be reassessed for FY25 after the October 1, 2024 Annual Meeting and prior to sending out invoices.

We appreciate that any increase in fees is a challenge to everyone's institutional budget. We have endeavored to keep these fees as low and as equitable as possible while ensuring long-term sustainability of the DS Catalog.

Specific changes include:

- 1. Adding a Level 6 to the "Number of Manuscripts" portion of the Tier calculation, for collections of more than 2500 records;
- 2. Adding a Tier 6 and changing how Tiers are assigned, as follows:
  - Score 0-3 = Tier 0
  - Score 4-6 = Tier 1
  - Score 7-8 = Tier 2
  - Score 9-10 = Tier 3
  - Score 11-12 = Tier 4
  - Score 13-14 = Tier 5
  - Score 15+ = Tier 6
- 3. Increasing dues for each Tier as follows:

Tier	Old dues	New dues
Tier 0	= \$0	\$ -
Tier 1	= \$500	\$ 750

Tier 2	= \$1000	\$ 1,500
Tier 3	= \$1500	\$ 2,000
Tier 4	= \$1750	\$ 2,500
Tier 5	= \$2000	\$ 3,000
Tier 6	n/a	\$ 3,500

- 4. A one-time records contribution and processing fee to be assessed for any new members joining after this year's annual meeting, as follows:
  - Tiers 1-2: \$500
  - Tiers 3-4: \$1000
  - Tiers 5-6: \$1500

Fees support DS member data management and enrichment and required maintenance of the DS Catalog database and search interface. Member fees also provide the foundation for a connected and supportive research community. The following reports give a glimpse into the growing usership of the DS Catalog since we started tracking analytics this summer: [by country](#), [by language](#), and [by webpage](#). We hope these reports will be helpful as you assess the value of your institution's participation in the DS community.
